## Residents Petition For Stoplight at Como and Doswell

A petition was circulated in St. Anthony Park asking the city of St. Paul for an electric traffic signal system at the intersection of Como and Doswell identical to the existing lights at Como and Carter. Currently city officials feel that the one-block spacing between the proposed signals and the existing ones is inappropriate, because the intersection is not highly dangerous, apparently meaning that more people have been killed at other intersections in the city than at Como and Doswell.

Hoping to persuade the city to reconsider its position, or if not to at least enter into discussions concerning alternative actions, the St. Anthony Park Association had petitions printed which explained the need for the proposed system. They collected signatures from business owners, employees, residents and users in North St. Anthony Park.

Basic reasons were cited within the request to the city. The business community has

expanded in the last few years, and observation reveals that street access to and from the major concentrations of residential property is hazardous, indicating an even greater need for signals at Como and Doswell than at the Como-Carter corner. With the new drive-in banking facility located on this corner, additional traffic flow problems exist when attempting to enter or cross, either on foot, or by bicycle or car. Bank officials estimate that 75% of their weekly regular banking transactions now take place at the new facility.

Given its isolated neighborhood qualities, St. Anthony Park has a much higher percentage of pedestrian and bicycle traffic; the ratio of people to vehicles would appear to constitute unsafe conditions.

Road design near the business district presents traffic problems. Coming from the west on Como, motorists face a one-half mile uphill stretch and often enter the curvature toward the business district at an unwise speed, especially considering the irregular pattern of entering cross streets. From the east a motorist, feeling the necessity for restraint over, is likely to accelerate, entering the intersection too fast also.

For these reasons the association felt justified in urging the community to petition the city for a variance in the criteria presently used to determine allocation. So far the city appears to be doing some additional observation of the corner, but no action has been taken.

## Where Have All The Fireworks Gone?

To celebrate Independence Day without the traditional fireworks display seems almost unAmerican to some residents of the area. Citizens of all ages will miss the annual pyroganza, often characterized as one of the finest in the twin cities.

In years past, the St. Anthony Park Association totally financed the project. Inflation, true to its ever pervading form, reflected noticeable increases in attempting to secure supplies, and board members cited cost as a prohibitive factor. In addition, the city recently tightened restrictions on firing conditions and additional expenditures would be required to meet current specifications.

Dr. Frederic Steinhauser, who engineered the display in the past, feels there were certain real hazards that jeopardized the safeness of the operation, lack of open space being an obvious factor.

In an effort to provide residents with a safe yet spectacular show, members of the association wrote to the Division of Parks and Recreation asking for an ariel display to be held at the fairgrounds. The city officials responded that the fairgrounds were not under their jurisdiction and recommended that residents attend city-sponsored displays in either Highland or Palen Parks.

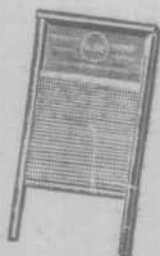

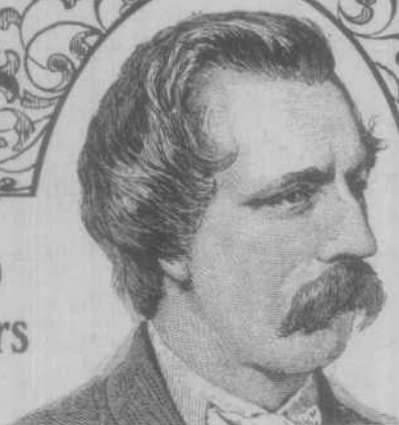

## St. Anthony Park



There are several ways the column might be filled each month: by the President, by committee chairmen, by invitation, by request, or by some other means yet to be determined.

This first column will be used by the President of the Association for the first of several discussions about educational policy in the state, the city, and our neighborhood.

Very briefly, the recent sequence of events is as follows:

Late April—St. Anthony Park is informed of District #625 Desegregation Plan that would change the use of Murray Junior and Senior High School to a Senior High School.

Late April—An entirely spontaneous and voluntary Ad Hoc Committee formed itself and scheduled and publicized a large public meeting at Murray on April 29.

April 29—Public meeting at Murray—About 375 attended.

April 30—City School Board adopted their plan.

May 13—City School Board presented the plan to State Board of Education for consideration and approval.

May 28—St. Anthony Park Association adopted a resolution for a broad based Ad Hoc School Committee.

June 5—Ramsey County Legislature Subcommittee hearing on school desegregation. A presentation was prepared by Ad Hoc Committee, but time ran out and was rescheduled for June 12.

June 10—State Board of Education approved the St. Paul plan. The School Board has two years to implement the plan. The Ad Hoc Committee presented information on the lack of community involvement to the Board.

June 12—Ad Hoc Committee information on lack of community involvement was presented to the Legislative Subcommittee.

The purpose of the Ad Hoc Committee should be clearly

understood by the community. The resolution establishing the committee was:

"That the St. Anthony Park Association sponsor an Ad Hoc Committee made up of community people that is broadly based to insure that our community is well informed and to support such action as would be generated by a community meeting called for that purpose."

This committee is expandable in terms of size and in terms of geographical representation. It was formed for the basic purpose of serving as a focal point for neighborhood discussion on this subject and as a tool of the community to use to keep the discussion open until all points of view and all alternatives have been heard and evaluated so that the community can make up its own mind, at public meetings based on the fullest amount of information.

This is the role of the Ad Hoc Committee. As the committee is able to establish public means of communication with the School Board, please come to the meetings and express yourself. By the time this column is published, one public meeting will probably be already past—a hearing by the Legislative subcommittee. There will be more public meetings in the future. Watch this newspaper and the daily newspapers for announcements.

## BENEFIT SCHEDULED AT LANGFORD PARK FOR EXCHANGE STUDENTS

AFS International will sponsor a chicken barbeque dinner in Langford Park July 4, from 5:00-7:00 p.m., under the supervision of chief chef Ben Pomeroy. Adults will be charged \$2.50 per plate and children \$1.75; all utensils, cups and plates will be furnished.

Proceeds from the event will be used to assist three exchange students; two coming here from Finland and Brazil, and one going from Murray High to Argentina.

## TRAFFIC NOISE ON 280 WILL DECREASE AFTER AUGUST RESURFACING

Area residents may find traffic noise on highway 280 reduced by about one third sometime in August. On July 26, contracts will be awarded by the Minnesota State Highway Department to resurface a portion of the road starting at North Pearl and extending almost to County Road B.

The Highway Department declared the stretch hazardous and secured federal funds to help support the resurfacing project. Because of the pitted and marred surface created by studded snow tires, skidding potentials and noise levels exceed ranges generally accepted as tolerable.

Two previous noise studies by the Hennepin County Public Works Department showed that bituminous overlay had definite sound abatement qualities. Careful application resulted in noise loudness reductions of 1/3, as perceived by the average person, and the ambient noise levels were made tolerable.







The biggest news at Commonwealth Terrace Co-operative this month is the opening of the first of 102 new units. The addition of these new units had its conception two years ago when residents vocalized the need for more student family housing. The members of the co-op were then able to carry through with their plan. Most of these initial units will be filled by present co-op residents who desire a transfer. For instance, families with three children will now have the option of renting a three-bedroom unit. Until now, they have been limited to a two-bedroom apartment. All new units will have two or three bedrooms.

Summer activities are in full swing with many co-op children participating in a Falcon Heights summer recreation program. Activities are geared to children ages three-five.

Many wards in the co-op are presently having neighborhood picnics. Some neighborhoods have initiated international dining at these picnics by having each family bring a dish representative of their country.



## SCHOOLS PROVIDING CONCENTRATED SUMMER PROGRAM IN THE ARTS

Three St. Paul public schools are cooperating in offering a program designed for children as a concentrated experience in several of the arts. Artist Lucy McAllister, dancer Linda Feinberg and poet Joanna Rukavina are working with 5th and 6th grade students from St. Anthony Park, Hill and Sibley elementary schools from June 24 to July 24 at the St. Anthony Park school. The students are creating their own expressions as well as exploring the various areas. A number of field trips are planned; the first occurred June 28 when the group went to view the Kerlan Collection at the University of Minnesota.

The goal of the West Midway-South St. Anthony Park Association is to secure the boundaries of the residential area of South St. Anthony Park, and prevent mixing of industrial and residential usage. To accomplish this goal, a plan has been formulated to redevelop some sections of the residential area, and to help homeowners rehabilitate and maintain their property in the other residential areas.

By July 1st the first phase of the residential redevelopment of South St. Anthony Park will be complete. The new Hampden Square apartment complex, on Hampden just east of Raymond Ave., will consist of 86 units of high quality family apartments. A large number of the new residents are students at the University. There are also a number of people who are employed in the nearby industrial area. About 20% of the new residents are really old-timers, those whose houses or apartments were acquired by the Housing and Redevelopment Authority and who elected to stay in South St. Anthony in our newest housing. A warm welcome to all the new residents. We're sure you will enjoy the good life in South St. Anthony.

## Some Good Ol' Fashioned Folk Recipies

#### LAVENDER WATER

1½ cups Alcohol (60 percent)  
1½ teaspoons Oil of lavender  
½ cup Rosewater

Dissolve the oil in the alcohol, then add the rosewater.

#### BUTTERMILK FRECKLE REMOVER

¼ cup Buttermilk  
1½ teaspoons Grated horseradish  
1½ teaspoons Cornmeal

Mix the ingredients and spread the mixture between sheets of soft white cotton. Place the cloth on the face, and leave it there for 10 minutes. After removing it, wash the face with an astringent lotion.

#### COCOA BUTTER LIP GLOSS

4 tablespoons Cocoa butter  
1 teaspoon Beeswax

Melt the ingredients together over low heat.

#### SHROPSHIRE HAIR COLORING [BLOND]

1 cup Rhubarb bark  
2 cups Alcohol  
Soak the bark in the alcohol overnight, then strain.

#### COCONUT OIL SHAVING MILK

3 tablespoons Lanolin  
2 tablespoons Coconut oil  
1 tablespoon Borax  
3 tablespoons Soap flakes  
2 cups Water  
1 cup Rosewater

Melt the coconut oil and lanolin together over low heat. Set aside. Heat the water, and add the borax and soap. Stir until dissolved. Add to the coconut oil and lanolin. Stir in the rosewater.

#### WEST INDIES AFTER-SHAVE

½ cup Alcohol  
½ cup Water  
1 tablespoon Glycerin  
1/8 teaspoon Menthol  
5 drops Oil of bay

Dissolve the oil and menthol in the alcohol. Add the remaining ingredients, and shake well. Let set for several days until it clears.

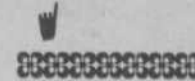

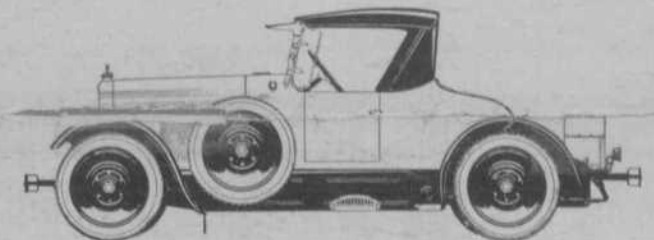
